Tuition Contract 2009 - 2010

Once the registration packet has been completed and returned, the interview process is finished, and acceptance is announced; the *non-refundable registration fee is due immediately.

Registration, book, activity and technology fees are non-refundable. They may be added to tuition and paid out in 10 monthly payments or may be paid in the summer when there are no tuition payments due.

Tuition options are as follows:

Monthly pay –

Option A: K3 & K4 – Tuition only

10 equal payments of \$280.00

* With this option, the Book/Activity/Technology fee must be paid in full by July 31, 2009.

Option B : K3 & K4 – Tuition with fees

10 equal payments of \$302.50

(If a student is enrolled after school begins tuition fees will be prorated to correspond with the date of enrollment.)

All other fees remain as stated above.

Additional students from the same **immediate** family (multi-siblings) will pay **tuition** as follows:

First (1st) student from the same **immediate** family will pay the regular rate. (Oldest sibling)

Second (2nd) student from the same **immediate** family will receive a 10% reduction.

Third (3rd) student from the same **immediate** family will receive a 25% reduction.

All payments not made within five working days will be considered overdue. A late charge of \$10.00 will automatically be added. A payment reminder call will be made the sixth day, and a registered or certified letter will be mailed the tenth day. Any account still delinquent after fifteen days may result in the suspension of the student until the account is current. A fee of \$15.00 will be assessed on all returned checks.

A student may not enroll for a new school year until all debts are cleared from the previous year. No grades, transcripts, test scores, or other information will be released by RCS until all financial obligations are paid in full.

Post-dated checks will be returned to the source of the check.

REGISTRATION POLICY FOR 2009-2010 SCHOOL TERM

K3 / K4 – Current R. C. S. parents are required to pay \$50.00 of the total registration fee by **March 31, 2009** to insure a slot for the coming fall of 2009. The remaining \$150.00 must be paid by June 30 of 2009 or the slot may be given to someone else. The multi-child discount for immediate siblings does not apply to the registration, book/activity fee or technology fees.

Parents are required to pay the \$200.00 registration fee by June 30 of 2009.

* A 10% penalty will be assessed to registration fees that are refunded through May 1. After May 1 registration fees are non-refundable.

Registration, book, activity and lab fees are non-refundable. They may be added to tuition and paid out in 10 monthly payments or paid in the summer when there are no tuition payments due.

Tuition options are as follows:

Monthly pay –

Option A: K5-6th – Tuition only

10 equal payments of \$290.00

* With this option, the Book/ Activity/Technology Fee must be paid in full by July 31, 2009.

Option B : K5-6th – Tuition with fees

10 equal payments of \$317.50

(If a student is enrolled after school begins tuition fees will be prorated to correspond with the date of enrollment.)

All other fees remain as stated above.

Additional students from the same **immediate** family (multi-siblings) will pay **tuition** as follows

First (1st) student from the same **immediate** family will pay the regular rate. (Oldest sibling)

Second (2nd) student from the same **immediate** family will receive a 10% reduction.

Third (3rd) student from the same **immediate** family will receive a 25% reduction.

All payments not made within five working days will be considered overdue. A late charge of \$10.00 will automatically be added. A payment reminder call will be made the sixth day, and a registered or certified letter will be mailed the tenth day. Any account still delinquent after fifteen days may result in the suspension of the student until the account is current. A fee of \$15.00 will be assessed on all returned checks.

A student may not enroll for a new school year until all debts are cleared from the previous year. No grades, transcripts, test scores, or other information will be released by RCS until all financial obligations are paid in full.

Post-dated checks will be returned to the source of the check.

REGISTRATION POLICY FOR 2009-2010 SCHOOL TERM

K5-6th grade – Current R. C. S. parents are required to pay \$50.00 of the total registration fee by **March 31, 2009** to insure a slot for the coming fall of 2009. The remaining \$150.00 must be paid by June 30 of 2009 or the slot may be given to someone else. The multi-child discount for immediate siblings does not apply to the registration, book / activity and technology fees. All K5-6th grade students pay the same registration fee of \$200.00.

Parents are required to pay the \$200.00 registration fee by June 30 of 2009.

* A 10% penalty will be assessed to registration fees that are refunded through May 1. After May 1 registration fees are non-refundable.
